In accordance with the regulations of the Ministry of Foreign Affairs of the People's Republic of China ,all foreigners go to China on business purpose need to present ,when applying for a business visa,an official invitation letter from the authorized Chinese organization .The organizers will coordinate and submit the applicant' s details to the Chinese authorities, the invitation letter will then be sent by electronic form to the applicant . The invitation letter from all spectators and exhibitors will only be sent to the electronic version, and the original will no longer be sent, because the embassy or consulate will no longer need the original.

Upon receipt of the invitation letter, the applicant is required to apply for an entry visa from the Chinese Embassy/Consulate concerned by presenting his/her passport and attach a copy, a recent photograph, a completed visa application form along with the required visa application fee.

You may also apply for a tourist visa for entry into China, which means you do not need to obtain invitation letter. Please contact your local visa office of the Chinese Embassy/Consulate for Tourist Visa Processes.

How to get an invitation letter:

- 1.Please submit your personal information.
- 2.Waiting ours to finish the invitation letter.
- 3.Please click the online payment link that we offer and complete the payment.
- 4.Send your invitation by email after you finish the payment.

Note:

- 1.Passport must be valid for at least SIX MONTHS beyond the intended date of entry to China.
- 2.Please make necessary copies of this form for each applicant. For Clarity, please type or print.
- 3.**Charge for issuing of the invitation letter USD30 for one person.**
- 4.**The embassy does not require the original of invitation letter this year.**
